### ISSUE AND ALLOTMENT OF 1,834,000 NEW SHARES PURSUANT TO THE EXERCISE OF 1,834,000 2021 WARRANTS

---

The Board of Directors (the “**Board**”) of Metech International Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) refers to the Company’s announcements made on 30 September 2021, 8 October 2021 and 19 October 2021 (“**Previous Announcements**”) in relation to the Proposed Placement cum Warrants Issue (as defined in the Previous Announcements). Unless otherwise defined, all capitalized terms used herein shall have the same meanings ascribed to them in the Previous Announcements.

The Board wishes to announce that the number of ordinary shares in the capital of the Company (“**Shares**”) has increased from 135,386,155 Shares to 137,220,155 Shares, following the allotment and issuance of 1,834,000 new ordinary shares in the capital of the Company (the “**New Shares**”) at an exercise price of S\$0.21 for each New Share on 5 November 2021 pursuant to the exercise of 1,834,000 unlisted warrants issued on 19 October 2021 (the “**2021 Warrants**”).

The 1,834,000 New Shares will rank *pari passu* in all respects with the existing Shares, save for any dividends, rights, allotments or other distributions, the record date for which falls before the date of allotment and issuance of the New Shares (i.e. 5 November 2021).

The 1,834,000 New Shares are expected to be listed and quoted on the Catalist Board of the SGX-ST on 10 November 2021 and trading of the 1,834,000 New Shares is expected to commence from 9.00 a.m. on the same date.

Following the exercise of 1,834,000 2021 Warrants into 1,834,000 New Shares, there are 14,839,250 2021 Warrants outstanding as at 5 November 2021.
